#### HOP drives economic health in WNC

The Healthy Opportunities Pilot (HOP) has not only made it possible for over **34,000 people** in North Carolina to live healthier lives — it has also become an economic engine for North Carolina's rural communities. A new study using input-output analysis shows HOP investments in Western North Carolina create jobs, raise worker income, and generate revenue for local businesses, many of which are still recovering from Hurricane Helene.

In just three years, HOP spending led to \$114 million in total business activity and created 898 full-time jobs that earned WNC workers \$36.1 million in employment income. These impacts include direct spending and ripple effects that stimulate other parts of the economy.

## **Understanding HOP's Economic Impact**



Every service dollar invested in HOP generated an additional **\$0.53** in economic activity in WNC.



WNC HOP services generated \$24 million in direct labor income and an additional \$12 million in income for other workers in the region.



WNC HOP services invested \$36 million in local wages and supported nearly 900 jobs across a wide range of industries and service sectors.








## **HOP Spending by** Sector in WNC

**Food Services Spending** 

HOP food services spending created \$74 million in total business, 555 jobs, and \$22.2 million in local wages.

### \$23.2 million

**Housing Support** 

Spending on HOP housing programs created \$35.2 million in total business activity, 293 jobs, and \$12.3 million in local wages.

### \$2.8 million

**Transportation** 

Spending on HOP transportation programs created \$4.8 million in total business activity, 50 jobs, and \$1.6 million in local wages.

### How does input-output analysis work?

I-O analysis shows how spending in one part of the economy generates revenue in other parts. For example, HOP home repair services employ construction workers, who then buy tools and spend money at local restaurants and stores. This stimulates the local economy by producing income for multiple businesses across a variety of sectors.
